## **House burns** in Clearlake late Friday

CLEARLAKE — Lake County Fire Protection District spent about an hour on the scene of a structure fire late Friday night. The fire reportedly originated in the chimney and spread to the attic area of the home.

Units were dispatched at 11:26 p.m. Friday, Jan. 23 following a report of a structure fire on the 3300 block of Brown Street in Clearlake. Units reportedly arrived at 11:34 p.m. to find the fire spreading to the upper portions of the structure.

"On arrival, the fire had already gotten through the protective structure of the chimney," LCFPD Battalion Chief Willie Sapeta said.

"This type of incident can easily be avoided with the proper chimney maintenance. We see a lot of chimney fires, but not usually to this extent where it had breached the protective house and extended into the attic and the eaves."

included Response the service of three fire engines, a rescue unit, a water tender, two medic units, two battalion chiefs and 25 personnel.

Units cleared the scene and were back in quarters

There were no injuries reported as a result of the fire. According to Sapeta, the occupants of the home were able to arrange alternate housing and the assistance of the American Red Cross was not necessary.

KELSEYVILLE — "The Lost

Sunday's performance was a free showcase concert for the band. The Lost Boys have entertained other venues such as charity events, battle of the bands and county fairs, but Sunday was the boys' first real-live, headlining concert. # Attorney pleas guilty in porn case

LAKE COUNTY - Robert Wayne Wiley, former Lake County Juvenile Court public defender, faces a maximum of three years in state prison for possession of child pornography in two separate 2007

incidents, according to prosecutor "There was a device located in the courtroom - a thumb drive – that was determined to belong to Wiley, and there was material on

it that fell within the definition of child pornography," Borg said. Wiley pleaded guilty Jan. 9 to a felony count of possessing child pornography in a Feb. 27, 2007

charge, relating to a Sept. 20, 2007 incident, was dropped in a plea

bargain but can still be considered

in sentencing. Wiley would also be required to register as a sex offender, according to Borg.

The case is under review for parole, a standard procedure, according to Borg. But because all of Lake County Superior Court's judges and the Lake County Probation Department have recused themselves from the case, Mendocino County probation officers are reviewing the case.

"Wiley worked in the juvenile system so long, and that is primarily run by the probation department because they work closely with the juveniles that are wards,' Borg said.

# **College looks** new direction for expansion

LAKE COUNTY – Property on Parallel Drive in Lakeport is no longer an option as Mendocino College expands its search for a permanent Lake County site to include property in Kelseyville, according to Michael Adams, the college's director of facilities planning.

The college has been in negotiations for almost two years to buy approximately 30 acres next door to its current 10,000square-foot location on Parallel Drive. Adams said the location would have been ideal, but an agreement could not be reached with the owner.

"They wanted twice as much as what we had," Adams said.

The college had the 30-acre property appraised three times over the course of a year, with the last appraisal late last year putting its value within the college's budget range for the Lake County facility. But even with a state match, the college could not afford the owner's asking price.

"Since we're using public money, we can't pay more than the market value," Adams said.

Mendocino College has instead shifted the parameters of its search. The college has leased the land it currently uses on Parallel Drive for almost 12 years, according to Adams, and is looking to buy land for its Lake County branch and build its own facility. While North Lakeport is not out of the question, Adams said the college is looking for a spot with existing water and sewer that will also allow for growth.

"We want to have at least what we have now, but with more efficiency. When you have to fit programs in the existing space, you have to compromise some things. We hope to initially increase our footage by 50 percent, and allow for growth as time goes on." Adams said.

Also part of the picture is that the state has withdrawn its match, meaning the college has cut its budget for the expansion

The development of a permanent Lake County site is an approximately \$7.5-million piece of the larger picture of expansions and improvements the college has in mind for its campuses in Ukiah, Lakeport and Willits. Voters approved \$67.5 million in Measure W bonds in November 2006 for the college.

Adams said the next step is to contact the owners of the sites he has in mind and
